Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER), which provides key information on the 2023-24 educational progress for Crestwood Middle School. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability, and teacher quality. For the 2024-25 school year, schools were identified based on previous years' performance using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that had at least one underperforming student subgroup in 2023-24. An Additional Targeted Support (ATS) school is one that had a student subgroup performing at the same level as the lowest 5% of all schools in the state in 2021-22. A Comprehensive Support and Improvement (CSI) school is one whose performance was in the lowest 5% of all schools in the state or below 67% in 2021-22. Some schools are not identified with any of these labels. In these cases, no label is given. Our school has not been given one of these labels.

Crestwood remains committed to increasing the number of students who are proficient in ELA and Math, as well as closing the achievement gap for our subgroups (Multi-Language Learners, Special Education, Black/African American) across state assessed subjects (Mathematics, English Language Arts, Science and Social Studies). Although we are continuing to see gains in achievement at Crestwood, Professional Learning Communities allow us to analyze data to determine which students are in need of specialized instruction and targeted interventions, and to ensure higher levels of learning for every student . Crestwood remains committed to providing the best, individualized instruction and support for all students. The iReady Diagnostic and MyPath platform allows us to measure academic progress and provide individualized instruction and practice in both Math and ELA. We offer STAR Club (Scholars Take an Active Role) after school three days per week where students get academic support from certified teachers. Some other key strategies include, but are not limited to:

- MTSS (Multi-Tiered Systems of Support)
- Emphasis on literacy across all content areas
- Intervention/support classes for Reading and Math
- Dedicated Daily Intervention Time (Falcon Flex) focusing on Math, ELA, and SEL

• School-wide Positive Behavior Interventions and Supports (PBIS)

ASSIGNING PUPILS TO THE SCHOOL

Students in Kentwood Public School District are assigned to individual school buildings based on the grade level they attend and the geographic area in which they live. School boundaries were developed with community involvement and can be viewed at the Kentwood Public Schools Administration Building at 5820 Eastern Ave. S.E.

SCHOOL IMPROVEMENT PLAN

Crestwood Middle School has an approved School Improvement Plan submitted to the State in which stakeholders have outlined goals and objectives that address student academic needs. Looking at a variety of data that measure student academic progress, we identified areas for improvement and research-based strategies to address these needs.

CORE CURRICULUM

Process: Kentwood Public Schools has aligned curriculum in all content areas with the Michigan Curriculum Framework and the Michigan Merit Curriculum. Benchmarks can be found on the Michigan Department of Education website: <u>http://www.michigan.gov/mde</u>. Our assessments and report cards are also aligned with the curriculum. Classroom instruction is congruent with the curriculum expectations and is monitored constantly by building principals and academic support personnel.

Alignment: Each grade level on the elementary level and each content area at the secondary levels meet regularly to study curriculum issues and to ensure that all students have common, equitable curricular experiences. A gap analysis is conducted annually with the M-STEP testing information and the curriculum is examined for areas of strength and weakness. After this audit, necessary adjustments are made.

Equity: "Excellence and Equity in Education" is the motto of Kentwood Public Schools. Common assessments with common scoring rubrics, and common curriculum materials help us work toward our goal of equity. In addition, principals and other evaluators have common instructional expectations that are used to guide teacher evaluation. Professional development, study groups, and constant communication between regular education, special education, and gifted programs also facilitate this process. We are committed to ALL of our students having multiple opportunities to learn and be successful in the core curriculum.
